Nioqqtissat pisiarineqarsimasut takuneqarsinnaasun- ngorlugit pisumit namminermiit nassarneqassapput.

Aalajangersakkanik atuuttunik unioqqutitsineq akiliisitsi- nermik pillaatissiisutaasinnaavoq.

Afgiftsfri indførsel af tobaksvarer, øl, vin og spiritus kan kun foretages af personer, der er fyldt 18 år.

Indkøbte varer skal medbringes personligt og synligt.

Ved overtrædelse af gældende bestemmelser, kan der idømmes bøde.

Duty-free tobacco products, beer, wine and spirits may only be imported by persons over 18 years of age.

Dutiable goods must be carried personally and visibly.

Offenders of present regulations are liable for fines.

- h) Sukkulaatinut mamakujuttunillu nioqqtissiat katillugit 4 kg,
- i) Kaffit imaluunniit tiit 4 kg, aamma
- j) Neqi, neqinit nioqqtissiat imaluunniit timmissat katillugit 5 kg.

Nioqqtissat eqqussat akileraaruteqartitaaneri akitsuuteqartitsinerlu pillugit Kalaallit Nunaanni aalajangersakkat

Angalasut Kalaallit Nunaannut tikinnerminni aallalernermin-niluunniit Kangerlussuarmi, Narsarsuarmi, Kulusummiilu nioqqtissanik akitsuuteqanngitsunik pisinissaminut periarfissaqarpit.

Nioqqtissanik akitsuuteqanngitsunik Kalaallit Nunaannut eqqussineq taamaallaat pisinnaavoq angalasup nunanit al-laniit, taamatuttaaq Danmarkimiit aammalu Savalimiuniit, tikinnermini nioqqtissanik nassarneratigut pisineratigul-luunniit. Nioqqtissat akitsuserneqanngitsut katillugit ima amerlatigisut eqqunneqarsinnaapput:

Grønlandske told- og afgiftsbestemmelser

Rejsende har mulighed for både ved indrejse til og udrejse fra Grønland at indkøbe afgiftsfri varer i lufthavnene i Kangerlussuaq, Narsarsuaq og Kulusuk.

Afgiftsfri indførsel af varer til Grønland kan kun ske ved at den rejsende medbringer eller indkøber varerne ved indrejser til Grønland fra udlandet, herunder Danmark og Færøerne. Samlet kan der afgiftsfrit indføres følgende mængder:

- a) 200 cigarettes or 50 cigars or 100 cigarillos or 250 g of smoking tobacco,
- b) 200 sheets of cigarette paper or cigarette wrappers,
- c) 1 liter of spirits (over 22 alcohol volume) or 2 liters of fortified wine (15-22 alcohol volume)
- d) 2,25 liter wine (less than 15 percent alcohol volume)
- e) 2 liters of beer
- f) 2 liters of carbonated beverages,
- g) 50 g of perfume and 250 ml of eau de toilette.
In addition, cosmetics and other toilet articles up to a total value of DKK 1,000.
- h) Up to 4 kilo of chocolate and sweets,
- i) Up to 4 kilo of coffee or tea,
- j) Up to 5 kilos of meat, meat products, or poultry.

Greenland customs and duty regulations

Travellers arriving in Greenland and departing from Greenland may purchase duty-free goods at the airports in Kangerlussuaq, Narsarsuaq and Kulusuk.

Duty-free import of goods to Greenland may only take place, if the traveller brings or purchases the goods when arriving in Greenland from abroad, including Denmark and the Faroe Islands. Duty-free import only includes the following total quantities:

- a) 200 cigarettes or 50 cigars or 100 cigarillos or 250 g of smoking tobacco,
- b) 200 sheets of cigarette paper or cigarette wrappers,
- c) 1 liter of spirits (over 22 alcohol volume) or 2 liters of fortified wine (15-22 alcohol volume)
- d) 2,25 liter wine (less than 15 percent alcohol volume)
- e) 2 liters of beer
- f) 2 liters of carbonated beverages,
- g) 50 g of perfume and 250 ml of eau de toilette.
In addition, cosmetics and other toilet articles up to a total value of DKK 1,000.
- h) Up to 4 kilo of chocolate and sweets,
- i) Up to 4 kilo of coffee or tea,
- j) Up to 5 kilos of meat, meat products, or poultry.
